3. Materials

Made from 100% natural wheat stems. No chemicals or coatings are added during the production process.

4. Intended use

HAY! Straws are intended to be used to drink various liquids and are not recommended to be eaten or consumed by humans.



5. Features

100% Biodegradable

Compostable in backyard and municipal composting facilities. Currently in the process of being certified by BPI and the USDA BioPreferred program.

Gluten Free

The product is gluten free and is safe for gluten intolerant people to use. Product is tested regularly to ensure that the gluten levels are under the GFO's recommended standard of <10ppm. Test results available upon request.

Never Soggy

Unlike paper straws, HAY! Straws do not get soggy and can withstand being in liquids for over 24 hours. They are smooth in texture and when sitting in liquids, they become pliable, like plastic.

Plastic-free Packaging

The product is packaged in unbleached, kraft cardboard and is printed with eco soy-based inks.

Glyphosate Free

Our product doesn't contain Glyphosate (Round Up). To ensure the safety of the product we batch test for over 500 chemical residues and are happy to report that these are all within food safe limits.

Non GMO

The wheat stems we use to produce the straws are made from non-GMO wheat sources.

Food Safe

HAY! Straws are manufactured using FDA Food Contact Safety Guidelines* and go through several sanitizing steps, quality checks to ensure the product is safe for use.

*The FDA only regulate drinking straws that have had chemicals added during processing, for example paper uses bleach and inks or stainless steel straws have been put through a multitude of chemical baths during processing. Our straws are 100% natural with no chemicals added during cleaning and processing. Because we are all natural, we fall outside of FDA's regulations and do not need to be certified to sell.

5" Cocktail (127mm)

7.75" Tall (197mm)

7. Diameter

Inner Diameter 3.5-5mm

Due to the natural nature of the product the diameter has variability.

8. Packaging

Retail - packed 100 straws/inner box

Wholesale - packed 500 straws/ inner box

9. Storage and shelf life

Store in a dry place away from direct sunlight and do not expose to temperatures exceeding 86°F or 30°C. The shelf life is 24 months if stored appropriately.

10. Disposal

HAY! Straws are intended as single use and can be composted after use. They will biodegrade within 3-6 months depending on composting conditions.
