- Regulation of the European Parliament EC 1935/2004 on materials and articles intended for food contact,
- Directive 94/62/EC on packaging and packaging waste and heavy metals,
- Regulation 2023/2006 of December 2006 on good manufacturing practise for materials and articles to come into contact with food and subsequent additions,
- CoE Resolution RESAP (2002)) 1 on Paper and board materials intended to come into contact with foodstuffs (April 2005).
- German BfR Recommendations on Food Contact Materials
- Dutch Packaging and Utensils Regulation (Warenwetbesluit verpakkingen en gebruiksartikelen)

The Ersatz paper may safely be used in packages or other products intended for direct contact with dry, moist of fatty foodstuffs.

- The paper bags are produced from Ersatz 45 gram and one or two types of glue Hotmelt for the end and a starch based bottom seam glue.
- Water based printing ink is used.
- The Ersatz paper is made from 100% virgin fibers from sulphate pulp. It does not contain any ecologically hazardous substances, and may safely be used in packages of other products intended for direct contact with dry, moist of fatty foodstuffs.
- The glue (Hotmelt) is a thermoplastic adhesive, that is 100% solid and does therefore not contain any solvents or water. It has strong bonding capabilities, especially between ersatz paper and the PLA.
- The bottom seam glue is an artificial resin dispersion in water for which no biological exposure limits are noted for the ingredients.
- PFAS free

Storage:

- The temperature range for the paper is 0° – 50° C. Storage in a dry place.
- Material is guaranteed for minimum 0.5 year after production date

This declaration does not apply if an article is used in other circumstances than described. It is in this case that the downstream user is responsible to comply with the relevant legislation.

PFAS substances are not used in the raw material and during the production of these articles.

This confirmation does not apply to the unintended use of the product(s) which can result in a change of composition or organoleptic properties of the product(s). The possible specific interactions between the food to be packed and the product(s) is for the user to be examined.

Confirmation is based on suppliers declarations, to the best of our knowledge.

This declaration is valid as long as no changes in the composition of the above product(s) and / or the relevant laws have taken place, in which case it will be renewed.

We recommend our customers to verify the regulatory status periodically.
